

ACCESS TERMS

Green Biotech Hellas – Website

1. Company Information

These Access Terms (“Terms”) are issued by:

In these Terms, the expressions “Green Biotech Hellas”, “we”, “us”, and “our” refer to the legal entity identified above.

2. Scope and Acceptance

These Terms govern access to and use of the password-protected area of the Green Biotech Hellas website (the “Website” and the “Restricted Area”, respectively).

By clicking “Enter”, submitting an access password, accessing the Restricted Area, or continuing to use it, you confirm that:

1. you are an authorized B2B client, institutional or business collaborator, or contracted research collaborator of Green Biotech Hellas;
2. You are accessing the Restricted Area exclusively for legitimate internal professional or business purposes;
3. where you act on behalf of a company, institution, organization, or other legal entity, you have authority to act on its behalf; and
4. you have read, understood, and agree to comply with these Terms.

If you are not authorized or do not agree to these Terms, you must not access or attempt to access the Restricted Area.

3. Authorized Access Only

Access is provided exclusively to authorized B2B clients, institutional or business collaborators, and contracted research collaborators (“Authorized Users”).

Access is personal to the authorized business relationship for which it was provided. It does not create any right of access for members of the public, consumers, unauthorized employees, subcontractors, advisers, or other third parties.

Green Biotech Hellas may, at its discretion and to the extent permitted by any applicable written agreement:

- issue, replace, or change access credentials;
- limit access to materials or sections;
- temporarily suspended access;
- revoke access; or
- discontinue the Restricted Area.

Access may be restricted, suspended, or revoked were reasonably necessary for security, maintenance, legal compliance, protection of intellectual property, prevention of misuse, or termination or modification of the relevant business relationship.

4. Nature of the Restricted Area

The Restricted Area is intended to contain general professional, scientific, technical, and informational materials relevant to authorized B2B relationships.

It is designed and intended not to host:

- Personal Data relating to clients, personnel, research subjects, patients, or other identifiable individuals;
- client-specific reports, results, deliverables, or datasets;
- confidential client data;
- confidential research data;
- medical records or health data;
- genetic, biometric, or other special-category Personal Data; or
- information intended to constitute a legally binding or regulatory determination.

Client-specific services, instructions, deliverables, data, reports, and communications are provided separately and are governed by the applicable written agreement, service request, purchase order, confidentiality arrangement, data-processing agreement, and/or other written instructions between Green Biotech Hellas and the contracting client.

Authorized Users must not attempt to upload, submit, transmit, or introduce Personal Data, confidential client information, or sensitive research information through the Website unless Green Biotech Hellas has expressly approved a specific secure process in writing.

5. No Public Offer – B2B Only

Nothing on the Website or within the Restricted Area constitutes:

- an offer or solicitation to the public;
- offers to consumers;
- a commitment to enter into a contract;
- a public scientific, laboratory, testing, certification, or consulting service;
- a quotation or binding commercial proposal; or
- a guarantee that any service will be accepted or provided.

All research and scientific support services are provided exclusively on a B2B basis and only under an applicable written agreement, accepted service request, purchase order, engagement document, and/or written instructions issued or accepted by a contracting client and Green Biotech Hellas.

Access to the Website or Restricted Area does not, by itself, create a client, advisory, fiduciary, partnership, agency, employment, joint-venture, or other professional relationship.

6. Separate Agreements and Order of Precedence

These Terms apply only to access to and use of the Website and Restricted Area.

They do not replace, amend, or expand any separate written agreement governing research or scientific support services.

If any provision of these Terms conflicts with an applicable written agreement entered between Green Biotech Hellas and a contracting client, the applicable written agreement shall prevail in relation to the relevant services, project, deliverables, data, confidentiality obligations, intellectual property rights, fees, responsibilities, and liabilities.

7. Professional and Informational Purpose Only

Website materials are provided solely for general professional, scientific, technical, and informational purposes within the applicable B2B framework.

Website materials do not constitute and must not be treated as:

- medical or healthcare services;
- clinical services or clinical advice;
- diagnostic or therapeutic services;
- patient-specific advice or interpretation;
- forensic services or legally determinative forensic evidence;
- legal or tax advice;
- regulatory advice, approval, clearance, determination, or submission;
- certification, inspection, conformity assessment, or official attestation;
- an accredited test report;
- a legally binding scientific conclusion;
- a substitute for professional judgment; or
- a substitute for client-specific deliverables and written instructions.

Authorized Users remain responsible for assessing the suitability of Website materials for their own internal purposes and for obtaining appropriate independent professional advice where necessary.

8. No Representation Regarding Accreditation or Certification

Nothing on the Website shall be interpreted as a representation that every service, method, activity, analysis, report, or deliverable provided by Green Biotech Hellas is accredited, certified, approved, or officially recognized.

Any accreditation, certification, approval, or recognition applies only:

- to the legal entity expressly identified in the relevant official certificate;
- within the scope expressly stated in that certificate;
- during the period for which the certificate remains valid; and
- to the specific activities, methods, locations, or services expressly included in the applicable scope.

Where relevant, the applicable written agreement or official scope documentation will identify whether a particular service or activity falls within or outside an accredited or certified scope.

G. Accuracy, Availability, and Updates

Green Biotech Hellas takes reasonable care in preparing Website materials. However, scientific, technical, legal, regulatory, and operational information may change over time.

Website materials may therefore be:

- updated;
- corrected;
- supplemented;
- replaced;
- withdrawn; or

- temporarily unavailable.

Unless expressly agreed otherwise in writing, Green Biotech Hellas does not warrant that Website materials are complete, current, error-free, suitable for every purpose, or continuously available.

Authorized Users must not rely on Website materials as the sole basis for medical, clinical, legal, regulatory, forensic, commercial, safety-critical, or legally determinative decisions.

10. Credentials and Security

Authorized Users must keep all access credentials, including any shared password, strictly confidential and secure.

Where credentials are supplied for use by an authorized organization, they may be disclosed only to personnel who:

- genuinely requires access for the authorized business purpose;
- have been authorized by the relevant organization;
- are subject to appropriate confidentiality and security obligations; and
- have been informed of these Terms.

Credentials must not be:

- published or posted online;
- sent to unauthorized people;
- included in publicly accessible documents;
- stored in an insecure or publicly accessible location;
- sold, transferred, or sublicensed; or
- used after authorization has ended.

Authorized Users must notify Green Biotech Hellas promptly at info@greenbiotech.gr if they know or suspect that:

- credentials have been lost, disclosed, or compromised;
- unauthorized access has occurred;
- a security vulnerability has been identified; or
- the Restricted Area is being misused.

Green Biotech Hellas may change or disable compromised credentials without prior notice where reasonably necessary to protect the Website or its Authorized Users.

11. Acceptable Use

Authorized Users must not:

- access the Restricted Area for an unauthorized, unlawful, fraudulent, or abusive purpose;
- attempt to bypass or defeat any password, access restriction, or security control;
- impersonate another person or organization;
- test, probe, scan, or assess Website security without prior written permission;
- introduce malware, malicious code, automated attacks, or harmful material;
- interfere with the availability, integrity, security, or normal operation of the Website;
- use bots, crawlers, scrapers, automated extraction tools, or systematic downloading tools;
- copy or assemble Website materials to create a competing database, service, publication, or product;
- remove copyright, trademark, ownership, confidentiality, or other notices;
- use Website materials in a misleading manner;
- falsely represent that Website materials have been approved, certified, endorsed, or issued for a purpose for which they were not intended; or

- facilitate access by an unauthorized third party.

Reasonable ordinary downloading or internal reproduction that is strictly necessary for the authorized purpose is permitted, subject to these Terms and any applicable written agreement.

12. Intellectual Property

All rights, title, and interest in and to the Website and its materials—including text, structure, design, graphics, images, documents, methodologies, templates, databases, trademarks, trade names, and other content—remain the property of Green Biotech Hellas and/or its licensors.

Subject to these Terms and any applicable written agreement, Green Biotech Hellas grants Authorized Users a limited, revocable, non-exclusive, non-transferable, and non-sublicensable right to access and use Website materials solely for the authorized internal business purpose.

Except where expressly permitted in writing, Authorized Users must not:

- reproduce Website materials beyond what is strictly necessary for internal use;
- distribute, publish, resell, license, or commercially exploit them;
- forward them to unauthorized third parties;
- incorporate them into public reports, publications, products, or services;
- modify them in a manner that misrepresents their source or meaning; or
- use Green Biotech Hellas names, logos, or trademarks.

No intellectual property right is transferred by access to the Website.

13. Confidentiality

Although the Restricted Area is not intended to contain client-specific confidential data, certain Website materials or access information may be identified as confidential or may be subject to confidentiality obligations under an applicable written agreement.

Authorized Users must:

- protect such information using at least reasonable professional and organizational safeguards;
- use it only for the authorized purpose;
- disclose it only to properly authorized personnel with a need to know;
- prevent unauthorized copying, forwarding, publication, or disclosure; and
- comply with any stricter confidentiality obligations in an applicable written agreement.

These Terms do not reduce or replace any confidentiality obligation contained in a separate written agreement.

14. External Links

The Website may contain links to websites, resources, or materials operated by third parties.

Such links are provided for convenience or information only. Green Biotech Hellas does not control and is not responsible for third-party content, availability, security, accuracy, terms, or privacy practices.

The inclusion of a link does not necessarily imply endorsement, approval, partnership, or responsibility.

15. Suspension and Termination

Green Biotech Hellas may suspend or terminate access where:

- authorization has expired or been withdrawn;
- the relevant contractual relationship has ended;
- credentials have been compromised;
- these Terms have been breached;
- access creates a security or legal risk;
- maintenance or technical changes are required; or
- suspension or termination is otherwise permitted under an applicable written agreement or mandatory law.

Upon termination of authorization, the Authorized User must cease accessing and using the Restricted Area and, where required by an applicable written agreement, delete or return downloaded materials.

Provisions relating to intellectual property, confidentiality, limitations of liability, governing law, and any provisions that by their nature should survive shall remain effective after access ends.

16. Disclaimer of Warranties

To the maximum extent permitted by applicable law, the Website and Website materials are provided on an “as available” and “as is” basis.

Except where expressly provided in an applicable written agreement, Green Biotech Hellas makes no express or implied warranty regarding:

- uninterrupted or error-free availability;
- compatibility with every device, system, or browser;
- completeness or continued currency;
- fitness for a particular purpose;
- merchantability;
- non-infringement;
- the absence of viruses or technical defects; or
- the results of relying on Website materials.

Nothing in this section affects any express obligation assumed by Green Biotech Hellas under an applicable written agreement.

17. Limitation of Liability

To the maximum extent permitted by applicable law and subject to any applicable written agreement, Green Biotech Hellas shall not be liable for indirect, incidental, special, or consequential loss arising solely from:

- access to or use of the Website;
- inability or delay in accessing the Website;
- interruption, modification, suspension, or withdrawal of Website materials;
- unauthorized use of compromised credentials where the Authorized User failed to apply reasonable security;
- reliance on general Website materials outside their intended purpose; or
- third-party websites or services.

This may include loss of profit, revenue, opportunity, business, anticipated savings, reputation, or data, to the extent such exclusion is permitted by law.

Nothing in these Terms excludes or limits liability for fraud, wilful misconduct, gross negligence, death or personal injury where legally applicable, or any other liability that cannot lawfully be excluded or limited under mandatory law.

Any specific liability arrangement contained in an applicable written agreement shall prevail in relation to the relevant contracted services.

18. Privacy and Cookies

Personal Data processing relating to Website visitors, technical logs, access-control events, cookies, similar technologies, and communications initiated through the Website contact details is governed by the Website Privacy Policy.

The Restricted Area is not intended to be used for the exchange or storage of client-specific Personal Data or confidential research data.

19. Changes to These Terms

Green Biotech Hellas may update these Terms to reflect changes in:

- Website functionality;
- security requirements;
- legal or regulatory obligations;
- business operations; or
- the nature of the Restricted Area.

The updated version will be published on the Website with a revised “Last updated” date.

Where a change is material, Green Biotech Hellas may require Authorized Users to review or accept the updated Terms before continuing to access the Restricted Area.

Continued access after the effective date of an updated version constitutes acceptance of the updated Terms, to the extent permitted by applicable law.

20. Severability and No Waiver

If any provision of these Terms is held to be invalid, unlawful, or unenforceable, the remaining provisions shall continue in effect to the maximum extent permitted by law.

A failure or delay by Green Biotech Hellas to exercise a right or remedy shall not constitute a waiver of that right or remedy.

21. Entire Understanding Regarding Website Access

These Terms constitute the understanding between Green Biotech Hellas and the Authorized User solely in relation to access to and use of the Restricted Area.

They do not replace or override any applicable written agreement governing contracted services, projects, deliverables, confidentiality, data protection, intellectual property, payment, or liability.

22. Governing Law and Jurisdiction

These Terms and any non-contractual obligations arising out of or in connection with them are governed by Greek law.

Subject to any mandatory jurisdiction rules and any different provision contained in an applicable written agreement, disputes arising out of or in connection with these Terms or use of the Website shall be subject to the exclusive jurisdiction of the competent courts of Athens, Greece.
